## PROVISION OF HOSPITAL SERVICES AT 58 HEALTH FACILITIES IN KHYBER PAKHTUNKHWA THROUGH PUBLIC-PRIVATE PARTNERSHIP REF NO HF020- 2022-23

- 1. Health Foundation in Khyber Pakhtunkhwa is mandated to promote and enable the development of innovative health care delivery models in the province. It aims to achieve policy objectives of Government of Khyber Pakhtunkhwa to improve quality and coverage through various means of Public Private Partnership for health care delivery services and matters connected herewith and ancillary thereto.
- 2. The Government of KP has recently approved its Health Policy, which was proceeded by a Health Sector Strategic Framework. The framework facilitates the implementation of Health Policy by providing a roadmap, to engage private sector in remote areas for improving community's access to quality services. It will also support the department in implementation of the approved health service delivery package at all healthcare levels. By outsourcing some Secondary Healthcare facilities, and focusing on the rest itself, this initiative will have two-fold benefits. One, it will bring private sector efficiency, accountability and management to Health facilities which have been a challenge for the Health Department to improve itself; secondly, it will free up more public sector resources to strengthen Health facilities and areas where Health Department's directly run service delivery is more effective.

- 3. Health Foundation Khyber Pakhtunkhwa now invites eligible Institutions/Organizations/Firms to indicate their interest in providing the services mentioned in ToRs. Any bidder expressing interest will need to demonstrate significant experience of managing similar projects in similar environments, preferably including work in the province or within Pakistan.
- 4. The bidder will be hired through the Quality Cost Based Selection (QCBS) competitive process as per KPPRA Act 2012 and Rules 2014, wherein the quality of the proposal and the cost of the services will be taken into account among short-listed firms.
- 5. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority.
- 6. Detailed EOI documents can be downloaded from the following official website <u>www.kphf.gov.pk</u>.
- 7. The Bidders shall indicate the order of preference of the clusters/Hospitals in which they are specifically interested as per form-4 of EOI documents.
- 8. Joint ventures/Consortiums are encouraged to apply.
- 9. The contract period will be 5 years.
- 10. EOI must be submitted till 11:00 am dated **25<sup>th</sup> Aug 2022.** The EOIs shall be opened at 11:30 am on the same date. Bid after due date and time will not be accepted.
- 11. The Procuring entity has the right to reject all bids under Rule 47 of the Khyber Pakhtunkhwa Public procurement Regulatory Authority (KPPRA) Procurement Rules 2014.
