**TERMS AND CONDITIONS:**

1. Tender forms & BOQs can be downloaded from Irrigation Department website [www.irrigation.gkp.pk](http://www.irrigation.gkp.pk) with effect from the date of publication of NIT in the newspapers till one day prior to opening date of the tenders. The Following documents (photo copies) shall accompany the bidding documents:-
  - a. Updated renewal of registration in Irrigation Department Khyber Pakhtunkhwa.
  - b. Registration with Pakistan Engineering Council valid upto last date of calendar year with relevant category and specialization code (CE-01 for work at S# I, CE-04 for S# II & CE-02 for S# III)
  - c. National identity card (attested copy).
  - d. The person whose name exists in Form "H"/Partnership Deed will only be entitled to sign the tender form, BOQ and all other contract documents. No proxy will be allowed to participate in the bidding.
  - e. 2% Earnest Money from any branch of Bank of Khyber, Khyber Pakhtunkhwa in the name of Executive Engineer, CRBC Irrigation Division DIKhan payable in shape of call deposit shall be appended with the Tender documents.
2. According to Provincial Government Notification No. KPPRA /M&E/Estt:1-5/2016 dated 24/05/2016 the Contractors / Bidders who quote their bids / rates more than 10% below the Engineer's Estimate shall submit an Additional Security in the form of call deposit equal to 8% of the bid cost along with the Bid. After commencements of work by the successful bidder, 8% call deposit may be replaced with a bank guarantee of the same amount from the scheduled bank.
3. The additional security shall be released to the contractor in four installments i.e 25% to be released after completing 25% of the project, 50% to be released upon 50% completion, 75% to be released upon 75% completion and the remaining amount to be released after completion of the project. In case the bidder quoted more than 10% below the tender cost (Engineer Estimate) and the bid is not accompanied by the additional security then the bid shall be considered as "Non-responsive" and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
4. The Contractors / firm should quote their rates on ABOVE / BELOW premium as all tenders shall be processed according to above / below system on BOQ based on MRS 2016.
5. Sealed bids sent through registered mail/courier should reach on 25.1.2017 upto 2:00 P.M, and will be opened on the same date at 3:00 PM, in presence of the bidders who intends to attend the opening. The delay in delivery of the Tender Documents will be the responsibility of bidders and shall not be entertained.
6. Tenders and copy of call deposits received through Fax or by hand will not be acceptable.
7. The competent authority reserves the right to accept or reject all or any bid by assigning cogent reason(s).
8. All Federal and Provincial Duties / Stamp duty / Taxes including sales Tax etc will be recoverable as per directives of the Government issued from time to time.
9. If any document submitted along with bid documents found false / bogus, the registration of the contractor/firms shall stands cancelled / black listed.
10. Any disfiguring / overwriting, manipulation in the tender shall be liable to rejection.
11. Incomplete/conditional bids shall not be acceptable.
12. In case bids become tie the award of contract shall be decided through a free toss which shall be binding and final.
13. The Bidders will be at liberty to enquire about any information from this office on any working day prior to last date of submission of tenders.
